AND to donate to institutions having objects similar to this TRUST.

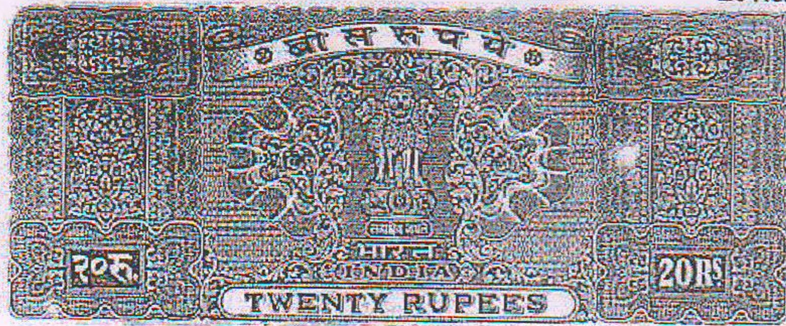

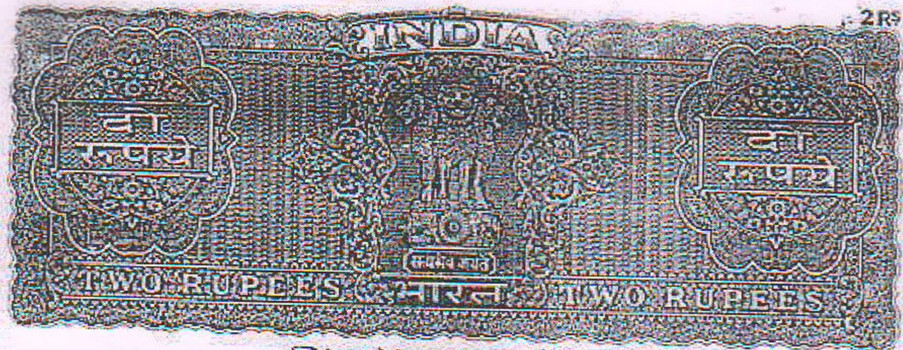

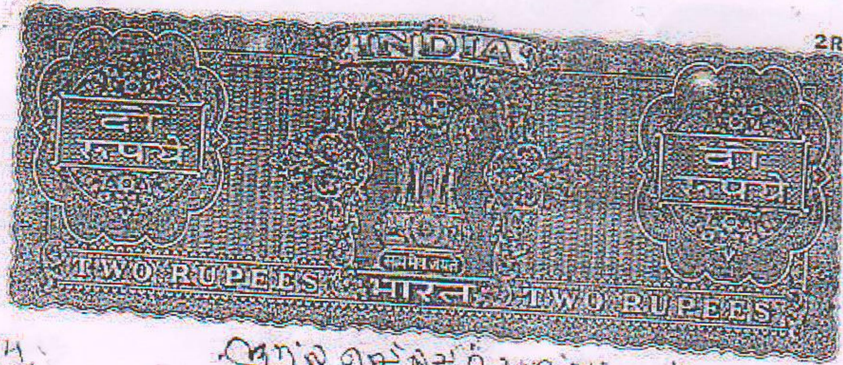
